**RE: PRODUCT APPROVAL FOR THE TAYLEX AUSTRALIA PTY LTD, PABSNR-1350+P AND THE
ABSNR-1350+P AERATED WASTEWATER TREATMENT SYSTEMS.**

We refer to your application seeking product approval for the above Taylex Australia Pty Ltd on-site wastewater systems.

Approval of the products is granted on the basis that the products have been certified by Global Certification Pty Ltd to conform with:

- AS/NZS 1546.3:2017 - On-site domestic wastewater treatment units – Secondary treatment systems, as demonstrated by Product Certificate of Registration Numbers 4383-3039-01 and 4387-3039-01, and
- AS/NZS 1546.1:2008 - On-site domestic wastewater treatment units – Septic tanks, as demonstrated by Product Certificate of Registration Numbers 4164-3039-01 and 040/7.

Pursuant to the South Australian Public Health (Wastewater) Regulations 2013, product approval is granted subject to the following conditions:

1. The approved secondary treatment system incorporates:
 - 1.1. A maximum treatment capacity of 1,350 L/day hydraulic load and 630 g BOD5/day organic load.
2. The products shall be manufactured and constructed in accordance with:
 - 2.1. The plans, drawings and specifications, as referenced in this approval.
 - 2.2. AS/NZS 1546.3:2017 – On-site domestic wastewater treatment units – Secondary treatment systems.
 - 2.3. AS/NZS 1546.1:2008 – On-site domestic wastewater treatment units – Septic tanks.

- 2.4. All other relevant standards and codes.
- 2.5. Conditions of this approval.
3. The seller of the approved products shall provide the purchaser with an electronic or hard copy of:
 - 3.1. The Owner's Manual, Taylex Advanced Blower System.
 - 3.2. Any other instructions relating to the installation, operation or maintenance of the products.
4. Modification of the design, materials or manufacturing process of the approved products or any of their associated components requires a variation to this approval by the Department for Health and Wellbeing.
5. The product approval will expire on 29 November 2027, at which time the products will no longer be approved and will be removed from the SA Health approved product database.
6. This product approval does not constitute approval for the installation of the product.

Pursuant to the SA Public Health (Wastewater) Regulations 2013

1. *The Department for Health and Wellbeing (DHW) may, by written notice, revoke the approval if satisfied that:*
 - 1.1. *The approval was obtained improperly.*
 - 1.2. *A condition of the approval has been contravened.*
2. *The DHW may conduct an inspection of an approved product to establish compliance with the submitted plans and the conditions of this approval.*
3. *The DHW may vary or revoke any or all of the approval conditions, or impose a further condition where:*
 - 3.1. *Variation, revocation or imposition is necessary in order to prevent or mitigate significant harm to public or environmental health or the risk of such harm.*
 - 3.2. *Reference to a new version of a manual is required.*
